After discussion, and having heard Mr Park in further explanation, the committee

- (a) agreed to the award of the following contracts:-
  - (i) contract 3164K Glasgow Roystonhill Stobhill Hospital (service 329) to JJ Travel at a cost of £16,275 for the contract period from 4 October 2015 to 15 July 2017;
  - (ii) contract W024D Townhead Coatbridge Cliftonville Carnbroe (service 117) to JJ Travel at a cost of £90,400 for the contract period from 4 October 2015 to 14 July 2018;
  - (iii) package 16567, containing contracts W094 Crosshouse Hospital Dundonald Irvine Magnum Centre (Service 21) and W095 Cumnock local (service 49A) to Western Buses at a cost of £294,228 for the contract period from 15 November 2015 to 14 July 2018; and
  - (iv) contract W100T Cumnock Kilmarnock (service X76B) to Western Buses at a cost of £51 per week for the contract period from 4 October 2015 to 2 April 2016 on a trial basis; and

After consideration of a report (issued) of 13 August 2015 by the Assistant Chief Executive (Operations) detailing changes to subsidised local bus services arising from changed circumstances, the committee noted the amendments as detailed below:-

Contract LS097M Antonine Park – Clydebank - Whitecrook (service 184/184A)	Alteration to route and timetable with effect from 22 June 2015 to provide residents with access to an hourly, Monday to Saturday daytime bus service and a link to Clydebank town centre, following withdrawal of commercial service 84 (additional cost of £2,447 per annum)
Contract W017D1 Kirkintilloch – Twechar - Banton (service 84/84A/84B)	Alteration to route and timetable with effect from 18 October 2015 to accommodate the operation of an hourly Monday to Saturday daytime service via Gartshore Crescent (no additional cost)
Contracts 9603D and W021C Croy – Twechar - Kilsyth (service 344/344A)	Alteration to the timetable and route of service 344/344A within contract 9603D and the timetable and route of service 344 within contract W021C with effect from 3 August 2015 as a result of the closure of Drumgrew Bridge (no additional cost)
Contract W064A Milngavie – Kirkintilloch (service 47/47A)	Reinstatement of contract with effect from 28 July 2015 following the withdrawal of all local bus services operated by Skyline Coaches (additional cost of £71,491 per annum)

Following discussion on additional costs incurred as a result of the Edinburgh Glasgow Improvement Programme (EGIP) and its impact on local bus services, the committee agreed that the Chair of the Committee should write to the Chief Executive of Transport Scotland

- (1) expressing the Committee's concern about the impact of works associated with EGIP on local bus services;
- (2) suggesting that it would be appropriate for Transport Scotland to shoulder more of the associated costs as the disruption was the direct result of a project of which they were the sponsor; and
- (3) requesting that Transport Scotland confirm whether or not any further closures or disruptions were likely and, if so, that they agree to meet the costs involved in maintaining

any affected bus services, rather than that cost having to be borne by SPT and/or local authorities.

## 9. Enhanced DRT funding application: Hospital Evening Visitor Service
