Minute of the meeting of the Strathclyde Partnership for Transport's Operations Committee held in Consort House, Glasgow, on 6 May 2011

1. Chair's Remarks

Before the commencement of the meeting, the Chair informed members that he had been advised that Councillor Ian Gray one of South Lanarkshire Council's representatives on the Partnership had taken ill. 2. Apologies

Apologies were submitted from Councillors Bill Grant, Marie McGurk, Tommy Morrison and John Reid.

3. Declaration of interest

(1) informing the committee of the latest trends in the number of passengers carried and the reliability of services directly operated and supported by the Partnership and on ScotRail services in the SPT area; and

(2) providing information on the current status of SPT's five point bus action plan for the continuing improvement of bus service delivery within the region, together with regulating and fleet profile statistics.

After discussion, the committee

- (a) noted the contents of the report; and
- (b) agreed that officers should contact ScotRail with regard to representation at future meetings of the committee.

6. Subsidised local bus service contract recommendations – financial implications Click here to view report

There was submitted a report (issued) of 27 April 2011 by the Assistant Chief Executive (Business Support)

- (1) advising the committee of the financial implications of members' possible decisions relating to further items on the agenda;
- reminding members that the budget for 2011/2012 included forecast inflation of 4%;
- (3) explaining
 - (a) that subsidised bus contracts included an annual inflation factor based on a combination of Consumer Price Index (85%) and Fuel Price Indicator (15%);
 - (b) that although both indices were subject to fluctuation, by the end of March they were over the budgeted level of 4%; and
 - (c) that although inflation would not be uprated until August, the current underspend was at risk.

After discussion, the committee noted the report in relation to the financial implications of awarding any contracts and agreed to give due consideration to these implications when making decisions on these contracts.

7. Homologation of award of subsidised local bus contracts 4199T Bellshill – Harthill and LS088T Hamilton – Coatshill/East Kilbride Local

With reference to the minute of 21 January 2010 (page 4, paragraph 7) when the committee had agreed to award contract 4199A Bellshill – Harthill (service 35,36) to First Glasgow (No 2) Ltd at a cost of £289,722 for the contract period 18 July 2010 to 13 July 2013, there was submitted and noted a report (issued) of 15 April 2011 by the Assistant Chief Executive (Operations)

- (a) that following operational difficulties with contract 4199A Bellshill Harthill, First Glasgow entered into discussion with SPT in November 2010;
- (b) that it was agreed that the contract be cancelled with effect from 12 March 2011 and a fresh tendering exercise carried out; and
- (c) that temporary contract 4199T Bellshill Harthill had been awarded to Stuart's Coaches Ltd at a cost of £2,256 per week from 13 March 2011 to 4 June 2011, in order that tenders could be invited for a longer term contract which was being considered at item 9 of the minute; and

(2) advising members

- (a) that temporary contract LS088T Hamilton Coatshill/East Kilbride Local (service 230/M1) had been awarded to First Glasgow (No 2) at a cost of £380 per week from 4 April 2011 until 16 July 2011, following the withdrawal by First Glasgow of commercial service 230 Hamilton Coatshill and service 31 between Lindsayfield and East Kilbride via Mossneuk on 15 January 2011; and
- (b) that in the intervening period, SPT would investigate whether suitable arrangements could be made with bus operators for the operation of commercially viable bus routes in those areas.

- contract LS083 Cambuslang Cairns Rutherglen (service 165) for the contract period 17 July 2011 to 12 July 2014;
- (ii) contract 4199B Bellshill Harthill (service 235/236) to Stuart's Coaches Ltd at a cost of £245,928 for the contract period 5 June 2011 to 13 July 2013;
- (iii) contract 6266R Ayr New Cumnock (service 343) to Western Buses Ltd at a cost of £504,277 for the contract period 17 July 2011 to 12 July 2015;

- (viii) contract 6941M Rankinston Ayr (service 347) to Western Buses Ltd at a cost of £105,928 for the contract period 17 July 2011 to 13 July 2012;
- (ix) contract LS080 Parkhead Carmyle Cambuslang (services 64,164,364) to First Glasgow at a cost of £238,680 for the contract period 17 July 2011 to 12 July 2014; and
- (x) contract LS084 Baljaffray Kelvinbridge (service 118) to First Glasgow at a cost of £66,248 for the contract period 17 July 2011 to 13 July 2013;
- (b) that based on the optional tender being awarded at item (iv) above, which provided an alterative enhanced timetable incorporating a Sunday service between Montgomerie Park and Irvine Cross, no award be made for contract LS5085 Montgomerie Park Irvine;

- (d) to the cancellation of contract LS035 Halfway Newton Village Burnside Rutherglen circular (service 7) and contract 4489E Cambuslang Parkhead Forge (service 308) with effect from 17 July 2011; and

(1) noted that SPT was in the process of developing a form to assess passenger eligibility for MyBus following the withdrawal of these assessments by the NHS; and

(2) agreed that a draft form would be submitted to this committee for members' approval,

there was submitted a report of 21 April 2011 by the Assistant Chief Executive (Operations)

- (a) informing members
 - (i) that SPT had now designed a form which enabled applicants to provide supplementary information in support of an application for MyBus membership; and
 - (ii) that the form featured a range of simple questions geared to determining what mobility issues might exist for an individual which impaired his or her ability to use mainstream public transport and requested access to the applicant's GP, if necessary, for the purposes of obtaining any required information;
- (b) enclosing the following appendices to the report:-
 - a MyBus information / application booklet;
 - a standard letter which would be issued in cases where the individual failed to meet the automatic criteria, but invited supplementary information in support of the application;
 - form MB1 for completion by applicants who did not meet the automatic criteria; and
 - a letter of acceptance which would be issued to applicants following assessment of form MB1;
- (c) recommending that the committee approve the revised procedures for processing MyBus applications; and
- (d) explaining that, subject to the committee's approval, details of the revised arrangements would be passed to all Chief Executives of SPT's constituent authorities for information purposes.

After discussion and having heard Mr Scott and Mrs Gold in answer to members' questions, the committee approved the recommendation at (c) above.

12. Councillor Mark Griffin
