Minute of the meeting of Strathclyde Partnership for Transport's Operations Committee held in 131 St Vincent Street, Glasgow, on 13 May 2016

To provide a bus service via the new housing development at Dunsmuir Park Estate in Kilmarnock (report item e)	Investigate options for provision of a service, including the use of any funding arrangements stipulated within the planning consent
