7. Funding arrangements: British Red Cross Society (North Ayrshire and Arran Transport and Escort Service)

With reference to the minute of 14 March 2008 (page 4, paragraph 7) when the committee had noted that SPT had provided funding of £43,822 to the British Red Cross Society (BRCS) as an interim measure while BRCS prepared a longer term funding proposal for the provision of a door-to-door transport and escort project in North Ayrshire and Arran which assisted the elderly, the infirm and the geographically isolated to attend healthcare appointments and visit relatives in hospital, there was submitted a report (issued) of 9 June 2009 by the Assistant Chief Executive (Operations) informing members

- (1) that BRCS had submitted a 3 year funding proposal to continue the programme at a cost of £217,874, which equated to £69,382 in 2009/2010, £72,479 in 2010/2011 and £76,013 in 2011/2012; and
- (2) that the total project cost over the 3 years was £263,948 with the balance of £46,074 being provided by a contribution from North Ayrshire Council and donations and fundraising from BRCS themselves.

After consideration, the committee agreed

(a) to grant fund the BRCS at a cost of £69,382 for the current financial year and subject to future commitment of grant funding, £72,479 in 2010/2011 and £76,013 in 2011/2012, given that the North Ayrshire and Arran project accorded with the aims of the Regional Transport Strategy and with the aspirations of the West of Scotland Community Transport Forum; and

8. Subway staff bus: award of contract

After consideration of a report (issued) of 5 June 2009 by the Assistant Chief Executive (Operations) advising the committee that SPT had historically provided a staff bus to assist in the transport to or from Govan of staff essential for the early and late operation of the Subway, the committee agreed to award a contract for continuation of the service on a modified basis as outlined in the report, to Lindon Travel who submitted the lowest compliant tender, at a cost of £116,325 for 36 months.
